SCC Items of Business:

- Fundraisers were discussed briefly and all were approved pending one question Principal Jenson is checking.
- It may be necessary to approve some field trips. We agreed that we will be able to do that electronically.
- We discussed next year's SCC. Some names were suggested for Chair, but none was approved yet. There will be some outreach to feeder school SCCs and we will see how many people are interested in serving next year before we see if elections will be needed in the fall. Discussed ways to build more contact with feeder schools and other non-represented populations.
- We discussed holding every third SCC meeting at a different location within the boundaries in the evening to try to boost attendance.
- We discussed the possibility of linking socioeconomic status with absence/attendance data, but that is not possible. It may be possible to link with zip codes, and to disaggregate the absences based on class to see if there are discernible patterns.
- We discussed the results of the community survey to name three school areas after Dean Collett, Pat Eddington and Larry Maxwell. The survey results were all in approval of all names, and the SCC concurred. This will now be submitted to the district.
- We discussed the school calendar for 2018-19. The administration plans to propose that there be late starts all year long.
- There has been a change in the advertising regulations for the signs along the fence at 2100 South. The signs cannot be up over the summer – they will correspond with the school year. A copy of Highland's G-14 form will be attached to the minutes.
